Many Paths of Natural Learning - Requirements and Responsibilities

Umbrella members must be on the MPNL Yahoo group Submit a join request including current contact info: name, address and phone number. You will need a Yahoo ID to use the yahoo group. It can be found at : http://groups.yahoo.com/group/Many_Paths_of_Natural_Learning/ Umbrella members **must maintain on-going communication** with the yahoo group at least weekly. MPNL management must be notified of any changes in your contact info including phone number, e-mail address and home address. Spouses or significant others are welcome to join the on-line group.

You must fulfill BOTH of the requirements - Annual visit and the End of Year Review form!!!

Annual visit –The Comar 05 requires annual visit(s) and follow-up visits as necessary. You need to attend at least one annual visit and get your annual visit form signed. This documents that we have met and had an opportunity to discuss your homeschooling program. You will fill out a form, which is an overview of your year, and you will receive a copy for your records. **Database for Field trips and Annual visit events** - We will post several events and field trip opportunities for your family to attend. We will fulfill our annual visit responsibility at these field trips. You will need to **RSVP** into the **database** adding the information required. A RSVP to the database is a **Commitment** that you will **attend and pay** the fee for the field trip. Please read the field trip and event policy on the files section. You may find the **Database** on the **MPNL Yahoo group**. It is your responsibility to look and see what events are posted and offered. You will need to attend at least one event.

End of year Review forms: Due by May 1st. Be sure to keep a hard copy of your review forms for your own records. Send two copies of your review form if you are in the High School Transcript Program. A 25.00 late fee will incur if forms are not received by May 15. The Comar 05 requires that we document our educational program. This is an overview and detailed description of your homeschooling program for all of the subjects usually taught in public school. **Document as you go throughout the year.** You may download the MPNL review form off the MPNL yahoo list. Include your educational resources, materials, and curriculum, which your child has used throughout the school year. Include valuable information such as field trips, lesson plans, unit studies, travels and other experiences. Check your calendar; many dates and experiences will be marked on your calendar and will jog your memory. Attach your own pages and add to your review form. You may also draw from **'Demonstrated Skills'**. You can document knowledge they show about a topic of conversation, math skills they use while buying toys and shopping, 'PE' stuff they do while playing, etc. **Include 'Resources Used'**. Write down the educational resources used; reading / library books, books on tape, movies, radio programs, field trips, people they have discussions with, web sites, subscriptions, newspaper, computer programs, and whatever else you come across in life that gives them exposure to learning. You can even make note of the grade level of the subject, especially if it differs from the actual grade.

Re-Enrollment You will need to send a **re-enrollment** form to MPNL by **August 15** of the new school year to be considered "continuously" enrolled in the umbrella program. If you miss the deadline, you will have to conduct a new pre-enrollment interview and pay the pre enrollment registration fee again.

The base fee for tuition has not been raised in 7 years. However, a small increase in per student fee has been increased by \$5.00 per student

MPNL's Highschool transcript program is \$125.00 per student per year.

Any bounced checks will be charged a \$25.00 fee.

You may request a payment plan of 3-payments. If you choose the payment plan for tuition, a \$25.00 fee will be added to your tuition. Payments will be due on the schedule of: **September 1, October 1, and November 1.** A 50.00 late fee will be assessed after November 1, if tuition is not paid in full. You must contact the director if you need further financial assistance by Dec. 31 or you will be removed as a member from MPNL umbrella.

A \$100.00 fee for an in home annual visit should you miss the official "Annual Visit" events. Payment will be due to MPNL prior to the visit. Must be scheduled by March and completed in April 30th of the school year.

We accept checks, cash and money order.

By pre request, we will accept Pay Pal transactions. A 4% service fee will be added for pay pal use. Pay Pal accepts major credit and debit cards. You will need to have a pay pal account set up to use. You must contact me first before using Pay Pal. MPNL has a special e-mail address that is attached to Pay Pal account.
